



# Fairplay Burro Days 2018



July 27 - 29, 2018 – Fairplay, Colorado

Dear Burro Days Exhibitor/Vendor,

The 70<sup>th</sup> Annual Burro Days and World Championship Pack Burro Race will be held Friday through Sunday, July 27 - 29, 2018, in Fairplay, Colorado. The attached sheets contain the application and map for all vendors/exhibitors.

We are providing this application for all the exhibitors attending Burro Days 2017 so that you may bring it to the Burro Booth during the event or mail it at a later date. During the 2017 event applications received with payment by the vendors/exhibitors currently occupying a booth space will secure that space on a “first right of refusal” basis. After the 2017 event booth spaces are reserved with payment only, and on a “first come, first serve” basis. Please note that we have very limited access to electricity. Electrical outlets will be reserved for vendors that need it to produce their products within their booths.

Vendors/exhibitors may set up their booths beginning at **5:00pm** on Friday, July 27<sup>th</sup>. We ask that vendors/exhibitors with space on the lawn set up five feet back from the sidewalk. Hours for all booths will be published as 9.30am – 4pm on Saturday, July 28<sup>th</sup> and Sunday, July 29<sup>th</sup>. **Please do not begin to close down before 4pm on Sunday, July 29<sup>th</sup>.** All vendors/exhibitors are asked to leave their area clean after the activities are over on Sunday. Trash cans are provided to dispose of any waste paper and other debris (additional trash bags are available at the Burro Booth).

**Please dispose of large pieces of trash and boxes in the large dumpsters provided.**

The deadline for all applications and fees is July 9, 2018. You will be notified by email of your assigned booth space upon receipt of your application with payment.

**All fees are non-refundable after July 1, 2018.**

All vendors attending Fairplay Burro Days must have a valid/current Colorado Sales Tax license. Licensing information may be obtained on the Colorado Department of Revenue website [www.taxcolorado.com](http://www.taxcolorado.com) or by calling 303-238-7378. Please allow ample processing time for these licenses.

**In addition**, the Park County Environmental Health Department requires **ALL** food vendors to have a current retail food license. At this time, Park County has asked that you complete your paperwork with the State of Colorado and receive your license directly from them. **Please call 303-692-3645 or email: [cdphe\\_laponduty@state.co.us](mailto:cdphe_laponduty@state.co.us) to learn more.** If you were approved in a prior year you are still required to apply for the current year.
